

## REPLACING YOUR LOST | DAMAGED LICENCE

If your Licence was misplaced or damaged, then you **must** apply for a Duplicate Licence to continue driving in Guyana.

### REQUIREMENTS

- ❑ A written report from the Guyana Police Force indicating the Licence **lost or damaged**; or An Affidavit from a Justice of Peace or Commissioner of Oaths.
- ❑ Copy of a valid form of identification (**National ID; Passport**)

### LICENCE FEE:

The cost associated with a Duplicate Licence is **G\$4,500.00**

## DRIVING IN GUYANA WITH YOUR FOREIGN LICENCE

A Foreign National visiting Guyana for a period **not exceeding sixty (60) days** will be allowed to drive in Guyana. However, he/she must be the holder of a valid driver's licence issued by the competent authority in the country of residence, and must have documents (**such as Passport**) which shows date of entry in Guyana.

## DRIVING FOR AN EXTENDED TIME?

If your visit exceeds the 60-day period, and you wish to continue driving, then you must obtain a **Foreign Driver's Permit**.

### REQUIREMENTS

- ❑ Completed Application Form
- ❑ A Valid Foreign Driver's Licence (**original and copy**). If licence is not in English, a translation of the document from the respective Embassy or International Language Institute must be presented.
- ❑ Original Passport

# Driving in Guyana

This document is not a substitute for the Law. In case of any misinformation, the Laws of Guyana shall prevail.

# Applying for a Provisional Licence

Any individual who has successfully completed their theoretical driver's examination, and wishes to drive in Guyana, **must** first make an application for a Provisional Driver's Licence. This licence **does not** qualify you as a Driver, and is issued on a temporary basis for your practical driving lessons, before the Guyana Police Force issues you with your competency letter.

The following documents will be required when applying for a Provisional Licence:

## 1 Completed Application Form

## 2 Copy and original of pass slip from the Office of the Traffic Police, Guyana Police Force (GPF)

## 3 Three passport sized photographs

## 4 Copy of valid form of Identification (National ID; Bio-data page of passport)

# APPLYING FOR A NEW DRIVER'S LICENCE

An individual applying for a new Driver's Licence will be required to ensure **all** documents are submitted to a Licence Revenue Officer, before the process can successfully commence. Additionally, persons making an application for the 'Plastic Card' Licence, **must** present themselves to the Licence Office, 200-201 Camp Street, to have their photograph taken. **NO third party WILL BE ALLOWED to make the application on behalf of an applicant.**

## REQUIREMENTS

- Completed application form
- Letter of Competence from the Certifying Office of the GPF
- Copy of a valid form of ID (**National ID; bio-data page of Passport**)
- One Passport-sized photograph

 **LICENCE FEE:**  
**G\$4,500.00**

**NOTE:** A **Provisional Licence** is valid for **three (3) months**, and can only be renewed up to **three (3) occasions**. Driver's Licences are valid for a period of **five (5) years**.

Persons under sixteen (16) years of age are **not** permitted to drive a motor vehicle, whereby persons who are seventeen (17) years old are **only** permitted to drive/ride a motorcycle.

# RENEWING YOUR DRIVER'S LICENCE

If your Licence is almost expired, the LRO can renew your licence at least **three (3) months prior** to the expiration date.

## REQUIREMENTS

- Present your Driver's Licence (expired /unexpired)

 **LICENCE FEE:**  
**G\$4,500.00**

**NOTE:** If you are the holder of the **"red-book"** Drivers' licence, the cost and requirements remain the same.
